#### **Earning Criteria**

- 3. Interview a local realtor to understand how property values are determined, and how local schools impact property values.
- 4. Create a short list of three to five budgeting priorities for local schools that improve outcomes for students over the next decade.

#### **Submission Guidelines & Evaluation Criteria**

The following are submitted to the module discussion board for engagement and evaluation:

I. How is your school district's annual school budget funded by local monies? State funding? Federal programs?

Find the district's documents and determine from where the monies come that constitute its fully funded operational budget.

What percentage of your school district budget comes from federal funding? How much of the budget is funded by the state? What percent comes from local revenue? Are there any other sources of funding beyond this?

Create a pie chart of your district revenue streams, indicating the percentage of funding that comes from federal, state and local dollars. Account for any additional sources of funding, as well.

When your pie chart is complete, share the visual in our EDInfluencer Advocacy Microcredential Incubator discussion group.

II. Compare the budget spending pie chart for the New York City Public Schools in School Funding: Where Does the Money Go? [3:48].

How do the percentages for each category they share compare with the corresponding categories in your school district?

Identify the strengths of where New York City spends their education dollars, then identify the strengths on where your local district puts its emphasis on student spending.

What are your takeaways from this comparison?

- 1. What does your local district get right in spending priorities?
- 2. Where does your local district's budget need to improve?
- 3. How will current funding streams impact your district's programs?
- 4. What are your personal priorities for budget planning for next year?
- 5. How can you share your ideas with other local stakeholders?

III. Realtors are an excellent source of information on the valuation of local properties and the taxes that are assessed on businesses and homeowners.

Schedule a meeting with a realtor in your community to learn about current property values and the taxes that are collected annually for schools.

Prepare a short list of questions to ask when you meet. Some possible items may include:

- 1. How are local property taxes assessed?
- 2. How do property tax rates here compare with other nearby areas?

- 3. What factors influence the rate at which property taxes are set?
- 4. Where are those taxes spent in the community?
- 5. What is the relationship between property taxes, schools and the quality of life in our community?

How does what you learn from this meeting inform your view about public funding of schools? How will this help you moving forward as an EDInfluencer?

- Describe how, if enacted, they can benefit your students
- Appeal to stakeholders and decision-makers for their support

- A visual organizer illustrating:
- Your budget priorities
- How they can benefit your students
- A call to action to stakeholders for their support
